

ACCA Exam Structure

Three years of relevant work experience



To be eligible for ACCA, you need to have completed Class 12 with at least 65% in English and Maths/Accounts and 50% in other subjects. Graduates and professional qualification holders (like CA, CMA, MBA) can get exemptions and start directly at higher levels.

Commerce Degree (B.Com, BAF, BBI, BFM, M.Com)	5 Exemptions	BT, MA, FA, LW, TX

Cleared IPCC without Graduation	5 Exemptions	BT, MA, FA, TX, AA
Cleared IPCC with Graduation	6 Exemptions	BT, MA, FA, LW, TX, AA
Qualified CA (ICAI)	9 Exemptions	BT, MA, FA, LW, PM, TX, FR, AA, FM




